**Rules and Guidelines**

1. All spaces are assigned by AVFA.
2. All canopies and tents are to be flame retardant and weighted down.
3. All set-up is to be completed one hour prior to gates open, no exception.
4. Vehicles are not permitted on the grounds during the event.
5. Vendors are responsible to set-up their own display and clean-up their area every evening. Trash bins will be provided on site. **All vendors are required to remain in their booth during event hours.**
6. All signage and decorations must meet AVFA approval.
7. The PBR is an outdoor event that may have inclement weather conditions. The AVFA is not responsible for any damage or theft of any goods, items or vendor display.
8. The AVFA shall have committee personnel at the event site from opening to closing.
9. All vendors shall obtain, at their own expense, licenses and permits required for operation, including but not limited to licenses and permits required by the State of California, the County of Los Angeles.
10. Vendor agrees to provide all service equipment, supplies and personnel, and to assume complete responsibility for the staffing and operation of their booth.
11. Alcoholic beverages are strictly prohibited.
12. All Commercial vendors are required to obtain a State Board of Equalization Permit prior to the event and post on site at all times. Vendors failing to comply with all rules will be asked to leave the premises without a refund.
13. Pets are not permitted on park grounds.
14. Vendor entry gates and parking shall be posted.

**Termination of this agreement:** The PBR is an outdoor event and will be conducted rain or shine. **The booth fee shall not be refundable due to Vendor's cancellation or failure to appear**
