# Local Amateur Talent Program

## General Information and Procedures

The Antelope Valley Fair solicits and encourages amateur talent to appear during the annual Fair. Individuals or groups may perform without cost.

1. The Fair reserves the right to: 1) audition any acts as to suitability 2) to limit material.
2. A maximum of 60 minutes will be allowed for an act to occupy the stage, including set up and dismantling time. This provides a 30 minute performance, with 15 minutes set up and 15 minutes teardown time.
3. The Fair provides pre-set general stage lighting and general sound with no more than twelve (12) microphones provided. Music and/or instrument amps are not provided.
4. Admission procedures for performers will be given when the completed schedule is sent.
5. Acts are cautioned not to store equipment or costumes in stage dressing rooms when unattended. The fair will not be responsible for lost equipment or costumes.
6. Pre-recorded sound for performances must be provided by the act in "***performance sequence***" on one electronic device. (phone or tablet)
7. The Fair reserves the right to schedule all acts at any time. Rehearsal time is not available.
8. Time space is limited to entertainment purposes ONLY (i.e. music, dance, theatrical, etc.). Requests other than entertainment will not be considered.
9. Release of liability forms will also need to be signed before an act can take the stage. Forms will be provided after the schedule has been announced.

**Please complete the enclosed forms and return them as soon as possible. Spaces are limited. Fair dates are August 16<sup>th</sup> through August 25<sup>th</sup>, 2019 .**
