Important AV Fair & Event Center (AV Fair) /COVID-19 (Coronavirus) FAQs:

1. Is the Antelope Valley Fair & Event Center open?

Due to County, State and Federal government guidelines regarding public gatherings during the COVID-19 pandemic, The Antelope Valley Fair & Event Center is closed to **most** general public events. The administration office is open; however, hours of operation vary. Please call ahead before visiting the administration office. The administration office telephone number is 661-948-6060. The Turf Club Restaurant and Watch and Wager are currently closed. The Antelope Valley Fair & Event Center has [cancelled or postponed select events](#) through July 31, 2020. Please continue to visit our website and social media channels for periodic updates. The AV Fair & Event Center also continues to work closely with our community health partners including the City of Lancaster, Los Angeles County and the Salvation Army in possibly utilizing select fairground facilities as secondary recovery health centers.

2. When will events return to AV Fairgrounds?

3. Is the Antelope Valley Fair & Alfalfa Festival still planned for August?

Due to the evolving COVID-19 situation, including its continued impact on community health and well-being, coupled with the rules and restrictions on large event gatherings, the 2020 Antelope Valley Fair and Alfalfa Festival (AV Fair) has been [postponed](#) until further notice. This includes concerts, still exhibits, motor events, carnival, concessions, commercial vendors, etc.

The safety of the AV Fair & Event Center visitors, vendors and the community at large, have and will always be the highest priority for Fair officials and staff. Based on the insights and guidance of the Los Angeles County Health officials and the State of California, it has become apparent that postponing the 2020 AV Fair is the prudent decision at this time; as the AV Fair & Event Center does our part to ensure the continued improvement of the community's health and safety, while minimizing the cycle of infection.
