Only animals owned and fitted by exhibitors in the Junior Livestock Classes or required to be shown in a Senior Department Class, State Rule VII, Livestock Ownership #1 are eligible. Novices in these events have **never shown any animal** in Fair competition, which includes small animals, dog, and horse projects).

Exhibitors shall be on hand and ready to exhibit at the time called for judging.

Note: All exhibitors are required to wear the official show uniform of the organization they represent.

Girls may wear slacks instead of skirts.

SHOWMANSHIP & WEIGHT REQUIREMENTS RULES: . State Rule: Livestock and Horse Exhibits, Ownership # 5.

1. If a market animal does not meet the weight requirement and thus cannot participate in the individual market class, there are specific rules for its use in showmanship.
2. **Single Animal Rule:** The animal can be used for showmanship only if it is the exhibitor's sole animal at the fair.
3. **Multiple Animals Rule:** If the exhibitor has brought more than one animal, the animal that does not meet the weight requirement can participate in local showmanship, but not in state showmanship.

1. Animals shown in Showmanship must be owned and fitted by the exhibitor, entered by the exhibitor and shown in an appropriate market, breeding/conformation, or performance class.

2. Junior exhibitors are expected to groom and care for their animal(s) while preparing for their show at the fair. They shall **NOT** accept active assistance from adults and non-exhibiting youth unless the junior exhibitor is actively engaged and a current AV Fair Large Livestock exhibitor, and the assistance is **ONLY** for instruction. The junior exhibitor (owner) **MUST** be there. State Rule VII, Livestock-Other #1.

3. **All entries in Showmanship MUST be entered by the exhibit deadline; exhibitors CANNOT enter the day of the show.**

4. During the judging and placing, exhibitors are urged to remain alert at all times to qualify for showmanship points.

***Order of Classes:**

ADVANCED FOLLOWED BY NOVICE (FFA) and SENIORS SHOW FIRST, FOLLOWED BY JUNIOR THEN NOVICE.

PREMIUMS OFFERED PER CLASS: 1st- \$10, 2nd-\$8, 3rd- \$6, 4th-\$4, 5th-\$2 Ribbons to 10th Place

A novice in this class has never competed in any showmanship class, whether large or small livestock, in Fair competition. An exhibitor will no longer be eligible for **any** novice showmanship class in subsequent years.

Date of birth of 4-H members **MUST** be on entry form.

Master Showmanship –Large Livestock

FFA, 4-H, Grange and Independent

Entry Fee: None

PREMIUMS OFFERED PER CLASSES: Ribbons to 10th Place

Note: Showmanship Jr. & Sr. 1st & 2nd Place class winners in Lamb, Beef, Swine, and Market Goat & Dairy Goats are eligible for Large Livestock Master Showmanship.

RULES:

1. Top two senior and two junior showmen for each species of animal will compete in Master Showmanship.
2. Exhibitor can't show their own or a family members animal.
3. All ten exhibitors in each class will show the same species of animal at the same time.
4. Event starts on **Tuesday, April 21 at 5pm.**
5. Each Exhibitor will show the following types of animals: Market Goats, Lamb, Beef and Swine.
6. Time limit: Eight minutes for each species of animal.
7. Exhibitor will be judged on their ability to handle the animal - not on grooming of the animal.
8. **All exhibitors who placed 1st, 2nd or 3rd in their species' showmanship must notify the Livestock Office whether or not they intend to participate in Master Showmanship. Notification must be made by Tuesday, April 21 at 10:00 a.m.**
9. **Fair Management will determine which 3rd place showmen are eligible to move up, based on the availability of open spots due to 1st or 2nd place showmen not participating. 3rd place showmen must be allowed to move up when applicable. In the event of a tie Fair Management will conduct a random draw.**
10. **All 3rd place alternates must check in with the Livestock Office by Tuesday, April 21 at 11:00am to confirm whether they have been moved up to show.**
