**Be sure to refer to all applicable state and local rules for the divisions you enter!**

**Entry Fee: \$3.00 per entry**

**Limit: One (1) entry per division per exhibitor, (space available)**

**Must have display completed and exhibitor must be out of the building by 7 p.m. or display may be disqualified**

**American System of Judging**

NOTE: Description, number of items in collection and space required for display must be in Description, also include daytime phone number, work, and cell number.

RULES:

1. 90% of exhibits must be articles never shown before at the A.V. Fair.
2. A collection must consist of no less than ten (10) items, and no more than space can be displayed nicely.
3. Locked cases approximately 2' x 4' x 2' will be provided. Liner sizes are back 48<sup>3</sup>/<sub>4</sub>" x 20", bottom 48<sup>3</sup>/<sub>4</sub> x 21<sup>1</sup>/<sub>2</sub>, and sides 21<sup>1</sup>/<sub>2</sub> x 20" The type of case will be the decision of the management.
4. Exhibitors must line the back, side and bottom of the display area.
5. Labels need to reflect:
  - A. The date collection was started
  - B. Description of collection
  - C. Date of oldest item in collection
  - D. Individual items may be labeled
6. Due to limited space, there will be one (1) Entry, per exhibitor per division. Cases will be assigned first come base. The receipt number on the entry form will be used for establishing the order.
7. Husband and/or wife will be considered ONE EXHIBITOR.
8. If an exhibitor is accepted and given a case but does not participate, they will be put on a waiting list the following year and not receive a case until all other applicants have received a case.

**Division Winners are selected from the first-place winners in each division.**

**Danish System of Judging**

**RULES:**

- 1. To qualify for a junior display, Junior must set up own display. If there is any adult participation, the display will be moved to the Family Division or disqualified.
- 2. Follow the rules in the Adult Collection Division.
- 3. Juniors will be assigned ½ cases unless there are extra cases available. ½ case liner sizes are back 24½" x 18", bottom 24½" x 21½" and sides 21½" x 18"
